ASSIGNMENT DESCRIPTION

IFC is supporting the Central Bank of Morocco (BAM) to improve the condition to create a secondary market for non-performing loans. In the earlier diagnostics, IFC identified the current treatment of debt transferability in the Civil Code a major obstacle, because of the lack of consensus over the definition of the term litigious receivable: this ambiguity deters investors as well as selling banks. To explore the optimal solution for the legal reform, BAM requested IFC to draft case studies. To respond to the request, IFC is soliciting the service of a law firm with experience in dealing with insolvency in various jurisdictions to prepare case studies.
