The National Office for Electricity and Drinking Water ("Office National de l'Electricité et de l'Eau Potable "or "ONEE"), here in after referred to as "the Employer", intends using part of the proceeds of a loan from the European Bank for Reconstruction and Development (the Bank) towards the cost of a Rehabilitation and strengthening of MIDELT's Production System Tendering for contracts to be financed with the proceeds of a loan from the Bank is open to firms from any country.

To be qualified for the award of a contract, tenderers must satisfy the following minimum criteria:

- The tenderer must have an average annual turnover of at least Two Million, Five Hundred Fifty Thousand Dirhams Moroccan Dirhams excluding tax (2 550 000, 00 DH HT MAD), which is the total of effected payments received for on-going and / or completed contracts during the three (03) years (2018-2019-2020).
- Experience as principal contractor in the context of at least two (2) contracts of similar work type and nature in the past ten (10) years that include:

Equipment or rehabilitation work on pumping stations with power greater than or equal to $20~\mathrm{kW}$
